 - o Princess: 6-10
- Age to compete as of July 1st 2025.
- Can not be married, not have been married.
- Can not be pregnant nor have been pregnant nor have a child.
- No visible tattoos.
- No stud horses allowed.
- No sharing of horses between any contestants for competition.
- Monochromatic outfits are encouraged, but not required.
- Denim jeans are allowed. Dark denim ONLY.
- Full western attire with hat and belt is required for all competition.
- Dresses, Business wear, or fashion forward outfit required for Speech, modeling and interview competitions. (Including Hat and Belt)
- Felt Hat required for all stages of competition and appearances. (No straw hat. No exception.)
- Sign Up:
 - Begin July 1st
 - End August 31st
- No Radius to compete. All contestants welcome.
- Competition is open to any young lady, regardless of if they have previously held the title of Springhill Rodeo Queen.
 - o Only current royalty is excluded from competition.
- 2025 Competition will be on Saturday, September 6th.
 - o Interviews: 9am (tentative) (Location Pending)
 - o Luncheon: 11 am
 - o Modeling & Speech to follow lunch.
 - Horsemanship: 7pm (Springhill Rodeo Arena)
- Each Miss, Teen & Princess contestant MUST:
 - Pay \$50 entry fee at time of entering
 - $\circ \qquad \text{Have ONE personal sponsor of $100}$
 - o Provide one "Silent Auction" gift (at least of \$30 value)
 - Silent Auction will conclude, Wednesday, September 17th. (Mutton Bustin')
 - Sale a total of \$1500 in combined sales of Raffle Tickets, Rodeo Tickets, Rodeo Sponsorships, Royalty Sponsorship and "Square Board".
 - o Additional sponsorship opportunities available.
 - Peoples Choice Award:
 - ONE overall peoples choice award will be given to the contestant who raises the most "people choice" money/ votes.
 - Peoples choice will be 1 vote per \$1 raised.
 - Peoples choice will be received through VENMO and at Pageant Luncheon.
 - Venmo will open up September 1st and will close on Friday, September 6th at Luncheon.
 - o Each contestant will have a people's choice bucket for cash at the royalty banquet.
 - Cash and Venmo will be combined for overall earnings.
 - People's Choice will be awarded at the Banquet on September 6th.
 - High Sale award will be awarded overall to the high money earner. (cash prize)
 - o Each contestant must provide 5x7 headshot to be used at Banquet, Contestant Packet and Social Media.
 - Head shot to be turned in with contestant packet by August 31st.
- Horsemanship patters will be age appropriate. Princess, Teen and Queen will all have separate patterns. Horsemanship patterns will be available August 15th.



Springhill PRCA Rodeo Royalty Rules

- ALL monies and sponsorships MUST be turned in on or before Wednesday, September 17th in Mail OR in person at (mutton bustin' qualifier) by 9pm. (other arrangements can be made if needed)
 - o Any contestant who forfeits themselves will still be responsible for turning in any and all sold and unsold raffle tickets and sponsorships by said date. Failure to do so will result in charges of theft by Springhill Rodeo Association.
 - o Any contestant who forfeits themselves will not be refunded any raffle/sponsorship monies or gifts.
- Each contestant:
 - o MUST ride in Rodeo Parade (Thursday, September 18th)
 - o MUST participate in Kids Rodeo (following parade) Springhill Rodeo Arena
 - MUST ride in Grand Entry of Rodeo each night (18th-20th)
 - ENCOURAGED to appear at "Mutton Bustin' qualifier" (17th)
- Each contestant will be encouraged to sale 50/50 raffle tickets during each night of the rodeo.
 - o Proceeds from 50/50 will be split between each girls total sales. (will not include non-compete divisions)
 - o Income from Silent Auction will be split between each girls total sales. (will not include non- complete divisions)
- Winner of each division will be required to sign a contract.
 - o Failure to comply with the royalty contract, prizes will be returned and given to 1st Runner Up.
- There is a "zero tolerance" for drama or bullying. This applies to Contestants and Parents. You will be given ONE warning and then asked to exit contest. (This applies to social media and in person.)
- If the winner of the MISS division decides to go onto her state competition, she will have the backing of Springhill Rodeo Association
- Springhill Rodeo Association and Royalty Director has the right to refuse entry into the competition.
- All judges scores are FINAL.
- In the event of a tie, the contestant with the higher INTERVIEW score will be declared the winner.
- Each contestant will receive a copy of their score sheets following crowning.
- Each contestant will receive a spreadsheet with each contestant's overall score in each division. (This will allow each
 contestant to see where they were strongest or need improvement.)
- Score sheets will be tallied by two auditors following the competition.
- To ensure full transparency and integrity of the pageant, the winners will be unknown by all parties (with the exception of auditors) until the moment of crowning!
- Each division will be awarded:
 - o Saddle- winner
 - o Crown- winner
 - o Buckle-winner
 - o Sash-winner
 - o Horsemanship Award in each division
 - o Speech Award in each division
 - Appearance Award in each division
 - Photogenic Award in each division (not scored)
 - Other Prizes and categories pending participation
- Overall Prizes will be awarded to:
 - o People's Choice
 - o High Sales
- Saddles will ONLY be awarded with a minimum of TWO contestants in each category.
